Annex 1 – Mandatory Conditions 1. No supply of alcohol may be made under the Premises Licence –

- At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
 - At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
2. Every supply of alcohol under the Premises Licence must be made, or authorised by, a person who holds a Personal Licence.
3. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

Annex 2 – Conditions consistent with Operating Schedule

1. Alcohol shall only be sold or supplied during the following hours: Mondays to Saturdays from 8.00am until 11.00pm, except on Christmas Day and Good Friday.
2. Alcohol shall only be sold or supplied on Sundays from 10.00am to 10.30pm, other than on Christmas Day.
3. On Christmas Day, alcohol shall only be sold or supplied from 12 noon to 3.00pm and from 7.00pm to 10.30pm.
4. On Good Friday, alcohol shall only be sold or supplied from 8.00am to 10.30pm.
5. The above restrictions do not prohibit:
 - During the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
 - The ordering of alcohol to be consumed off the premises, or the dispatch by the vendor of the alcohol so ordered;
 - The sale of alcohol to a trader or club for the purposes of the trade or club;
 - The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces.
6. Alcohol shall not be sold in an open container or be consumed in the licensed premises.
