On balance, the needs of electors to travel a shorter distance and avoid crossing a busy road and to stay within the perceived boundary of their estate coupled with the reasonable adaptations that can be made in allowing electors to vote secretly at a temporary station weighs greater than the benefit gained in a more accessible station further away in a different polling district.
